



## Rules and Regulations

- A valid Campus Recreation Membership is required to rent a bike.
- Availability is not guaranteed. Rental is on a first come, first serve basis.
- Reggie Ride bikes must be returned by the end of the Student Fitness Center business day.
- There is a \$10 late fee per day for unreturned bikes.
- Helmets are not required, but users are strongly encouraged to wear them. Helmets are available to rent at the Welcome Center.
- Bike racks are the proper place to park bicycles. There are racks located throughout campus and the community. It is the responsibility of users to ensure that bikes are parked and secured properly. Locks are provided to the renter by the Student Fitness Center.
- Equipment must be returned by the same person who checked out the equipment.
- The renter is responsible for that piece of equipment until it is returned. In addition, individuals will be charged a fee for damage or loss of equipment. These fees will not exceed \$264.
- Renter agrees to follow all University policies, laws, and regulations. Specifically, but not limited to all traffic and safety rules related to bikes.
- Renter agrees they will not, under any circumstances, use, ride and/or operate the bicycle after consuming, ingesting and/or using alcohol or drugs and/or if the renter has a blood alcohol concentration about the jurisdictional limit prescribed.
- Renter agrees to immediately report a stolen or lost bicycle and/or key to the Department of Campus Recreation and/or Campus Police. The renter is responsible and liable for any misuse, consequences, claims, demands, causes of action, losses, liabilities, damages, injuries, costs and expenses, penalties, attorney's fees, judgments, suits, or disbursements of any kind or nature whatsoever related to a stolen or lost bicycle.
- Upon the return of the bicycle, the renter must take part in an inspection of the bicycle after use, riding and/or operation. A Facility Manager will examine and test the bicycle's operating parts including but not limited to: the brakes, lights, steering apparatus, tires, pedals and lock, once the renter returns the bicycle.
